

Director Scheuneman asked if there were any corrections or errors and there were none noted. A motion was made by Branch Secretary Dorothy Andrzejewski, second by Sylvia Kowalski to accept the treasurer's report. Director Scheuneman called for a vote. Motion passed unanimously.

Old Business: Dine to Donate: Julie Andrzejewski reported that Patty Evanchyk set up the dates at the Texas Roadhouse. We will be in Wilkes-Barre on September 16 and in Dickson City on September 19. The hours are 3-10pm and District 1 will receive 10% of the total food bill within two weeks of the event. Invitations as well as notices for the bulletins were sent out to local churches in District 1 & 8.

People will need to show the paper invitation or the invitation on their phone in order for District 1 to receive the 10%. Both events are on the PNU Facebook page.

Postcards were sent out. We will have a basket raffle at both locations. Julie Andrzejewski is gathering donations for the baskets. Education and Youth Raffle: Tickets are \$5.00 each or 3 tickets for \$10.00. First prize is \$400 cash, second prize is Amazon Echo, third prize is \$100 cash. Tickets were passed out to those in attendance to try to sell. Lion King: The Lion King movie event did not happen. Vice President Mari Jane Stankowski suggested that we plan for Frozen II which is to be released Thanksgiving Weekend. The first weekend in December was decided upon. Director Scheuneman will make arrangements with Cinemark in Moosic.

New Business: Spojnia Sunday: Is held on the fourth Sunday in September. This year it falls on September 22. Director Scheuneman asked the secretaries to try to have a remembrance of Irene Jugan. The Irene Jugan Heart and Soul Award: Nominations should be sent to PNU CFO John C Andrzejewski III by September 15. The winner will be announced at the 31st Convention. Christmas Party: After a discussion was held by those in attendance, it was decided that the Christmas party will be held in the Lower Level of the PNCC building tentatively on December 12 at 6 pm with Gary Kaspriskie catering. Reorganization Meeting: This to be determined as the district directors will be appointed after the 31st Convention.

The next meeting will be held tentatively on December 12 at the Lower Level of the PNCC Building in Scranton at 6 pm.

A motion to adjourn was made by Mary Ann Stankowski. Meeting adjourned at 8:05 pm.



**District 10 PNU Meeting February 16, 2019**

BVMC Parish, Latham, NY

District 1- Director George Urciuoli called the meeting to order at 10:05 AM. In attendance were: Fr. Sr. Marian Pochiecha (by conference call), Rev. Mark Gnidzinski, Rev. Jim Konicki, George Urciuoli, Thomas Zembrzuski Sr (Br. 126 Sec), Richard Mossey, and Regina Pollack. Fr. Sr. Marian offered the Invocation. George thanked everyone in attendance and reviewed the purpose of the meeting.

**Election of Convention Delegates-** the notice of today's meeting was published in Straz, in accordance with the PNU Constitution.

A) Convention Dates: September 29-October 6 aboard the Royal Caribbean.

B) District 10 is allowed 2 delegates, in addition to the District Director (who attends automatically)

C) Fr. Jim nominated Regina Pollack, 2<sup>nd</sup> by Dick Mossey. Regina accepted the nomination and was elected unanimously.

D) There were no other nominations; George said we have time to talk to our members before the deadline for delegate elections (June 1). Copies of the Feb 2019 Special Edition of the STRAZ were distributed and will be sent to the Mohawk Valley Seniorate clergy. The Special Edition STRAZ details the responsibilities of being a delegate, qualifications, and delegate reimbursement rules. George stated that we can convene again for this purpose at the April 6 Seniorate Lenten Retreat, which will be held at the BVMC Parish in Latham.

**Reviving inactive Branches within District 10**

George shared the membership lists with those in attendance. Fr. Jim is attempting to reactivate Branch 140 at the Holy Name of Jesus Parish in Schenectady. Fr. Jim is also reviewing Branch 168, many of whom belonged to the now-closed Amsterdam parish. Fr. Sr. Pochiecha was also very interested in obtaining the list for Rome and Syracuse.

George said he will send each seniorate pastor a copy of their list to review and this can serve as a starting point. It was noted the lists may contain individuals who have died, moved, are no longer parishioners, or simply unknown. We will ask each pastor to try to identify as many as possible on their lists, which may entail working with the elders of the parish who have the history. George also suggested we conduct a brief survey of our parish's age demographics so we can determine how to target the various PNU products to the different demographics we have. He will develop a brief survey so that we can outline a plan for discussion when we meet together at the April 6 Lenten Retreat.

**PolsihFest 2019:** Planning is underway and Branch 126 will again provide an information table during the 3-day event. Discussion centered around how to better promote the PNU and its products to the 6,000 people who attend the festival. The Kidz' Zone will be managed by Alyssa DePaula (HNofJ), with all proceeds committed for the benefit of the Seniorate Youth. We will ask our youth to assist managing the area.

**Summary :** George will send Seniorate clergy a letter including minutes of today's meeting, the list of PNU members from their inactive branches, the February 2019 Special Edition of the STRAZ, and a demographic survey. Fr. Senior Pochiecha will include the PNU on the agenda for the Seniorate Meeting that will follow the Lenten Retreat.

**Report of Actions Taken by the Board of Directors of the PNU during a regular board meeting held September 12, 2019**

OPENING

A regular meeting of the Board of Directors of the Polish National Union of America was held on September 12, 2019 via teleconference. The meeting was opened by CEO Maycan. Seven Board members were present and 2 were absent. A member of the Internal Audit Committee was also present.

Minutes

The minutes for the regular board meeting held June 6, 2019 and minutes for special meetings held on July 1, 2019 and July 18, 2019 were distributed prior to the meeting. CEO Maycan asked for corrections or additions. There were no corrections or additions made.

A motion was made and seconded to accept the minutes from the regular meeting held June 6, 2019; the special meeting held July 1, 2019 and the special meeting held on July 18, 2019 as presented. The motion passed.

STANDARD REPORTS

Standard reports for Spójnia Inc., monthly membership, and the Second Quarter Statement were given during this portion of the board meeting. Each report was considered separately with respect to any discussion and questions. All reports were distributed to the PNU Board of Directors prior to the meeting. Time was allotted for discussion and questions.

During the Spójnia Inc report proposed changes to the Spójnia Inc. Articles of Incorporation were reviewed with the board. The board engaged in discussion noting that there were two changes proposed.

At the conclusion of the report regarding Spójnia Inc. a motion was made and seconded to accept the report. The motion passed.

After review and discussion regarding the Membership Report and the 2<sup>nd</sup> Quarter financial statement a motion was made and seconded to accept the standard reports. The motion passed.

CHIEF EXECUTIVE OFFICER'S REPORTMortgage Department

The board was updated with regard to activity in the mortgage department. No action was required.

At the conclusion of the CEO's report a motion was made and seconded to accept the report. The motion passed.

CHIEF FINANCIAL OFFICER'S REPORTExonerations

One exoneration was brought before the board for consideration. The certificate meets the requirements established by the board for exoneration. They include being at least 80 years old, in force for at least twenty years and having paid more in premium than the face amount of the insurance coverage. A motion was made and seconded to accept the exoneration. The motion passed.

Correspondence

CFO Andrzejewski noted that four thank you notes were received.

Personnel

CFO Andrzejewski updated the board with respect to the personnel.

Penetration Testing

The results of the test were received in the office and transmitted to the IT vender.

State Meeting

CFO Andrzejewski reported regarding the results of a periodic meeting with the State of PA Insurance Department.

Promo Programs

The board was brought up to date regarding progress on the promotional programs. The two programs discussed were the annuity anniversary rate program and the Cheers to 111 Years insurance offer. The Promotions topic was the last item under the CFO's Report. A motion was made and seconded to accept the report. The motion passed.

COMMITTEE REPORTS: Investment Committee

Chairman Maycan indicated that the committee did not meet prior to the board meeting; however recommended that the board keep mortgage and annuity rates the same as set for the third quarter ending September 30, 2019 for the fourth quarter ending December 31, 2019 with the exception of the 111<sup>th</sup> anniversary promo rate. That rate would be temporarily set [3.25% for one year for deposits of \$1,000 to \$11,110 and a rate of 4.36% for one year for deposits of \$11,111 or more] as previously discussed. After a brief discussion a motion was made and seconded to approve the recommendation. The motion passed.

The rates are as follows:

The annuity rate for all new issues and annuities issued after 12/31/2012 will be set at 2.5%. The annuity rate for issues prior to 1/01/2013 will be set at 3%. The residential loan rates would be set at 5% for twenty years, 4.75% for fifteen years and 4.5% for ten years.

The Commercial loan rates would be set at 5.5% for twenty years, 5.25% for fifteen years, and 5.0% for ten years.

Anniversary special rate of 3.25% for one year for deposits of \$1,000 to \$11,110 and a rate of 4.36% for one year for deposits of \$11,111 or more on new annuity accounts opened on or before September 30, 2019.

Spójnia Credit Union

A verbal report was given by CFO Andrzejewski. Highlights of the credit union financials and promotional activity were reviewed with the board.

Fraternal Activities Committee

The board noted that a financial statement was distributed prior to the meeting. There was no discussion.

Education and Youth Commission

A written report and financial statement were submitted to the board prior to the meeting. The report included a summary of the work of the commission. There was no discussion.

**Report of Actions Taken by the Board of Directors of the PNU during a regular board meeting held September 12, 2019 Continued**

Internal Audit Committee

CEO Andrzejewski noted that the Internal Audit Committee report was received subsequent to the June meeting. The report was distributed to the board prior to the meeting and contained one recommendation.

The recommendation is as follows from the report: "The IAC continues to encourage all District Directors and their Officers to submit meeting notices, meeting minutes, articles, photos, etc."

The recommendation was briefly discussed. A motion was made and seconded to accept the recommendation. The motion passed unanimously.

A second report from the IAC was submitted to the board. The report is the Act 154 report. The board noted that there were no discrepancies found according to the report.

A motion was made and seconded to accept the Act 154 report. The motion passed.

A motion was made and seconded to accept the Internal Audit Committee report. The motion passed.

District Reports

The Board noted that reports were received from Districts 1, 2, 3, 5, 6 and 10. A report was not received from District 4 and 7. District 8 currently has no District Director in place.

The Board engaged in discussion regarding the reports. At the conclusion of the discussion a motion was made and seconded to accept the reports of the District Directors. The motion passed.

OLD BUSINESS

Spójnia Park

CFO Andrzejewski reported on activity associated with the sale of the property. No action resulted.

Convention

Delegate Count

CFO Andrzejewski reported the count of delegates registered to attend the 31<sup>st</sup> General Convention.

Credentials Committee

The board noted that due to an oversight the Credentials Committee was not approved at the June 6, 2019 meeting. The committee was approved subsequent to the meeting via email. A motion was made and seconded to ratify the action of the board and accept the committee as named. The motion Passed.

Convention Committees

The board engaged in preliminary discussion regarding the potential appointees to positions and committees of the convention. A sheet listing previous appointments and suggested appointments was distributed to the board. The document included suggestions for filling the vacated positions.

At the conclusion of the discussion a motion was made and seconded to recommend the convention committees be filled as presented to the board. The motion passed.

Vice President Stankowski took note of the recommended appointments as she will be making the announcement at the convention.

Agenda

CFO Andrzejewski noted that the agenda as published in the constitution and bylaws was distributed to the delegates as the initial agenda.

Delegate Meetings

CFO Andrzejewski noted that a delegate meeting schedule was distributed to the board. Meetings have been scheduled with all of the districts.

During the segment about the delegate meetings the board engaged in discussion regarding the appointment of the District Directors should the constitutional changes be approved. No action resulted from the discussion.

At the conclusion of the discussion about the convention a motion was made and seconded to accept the convention report. The motion passed.

Spójnia Sunday 2019

Director Kathy Nemkovich reported on progress regarding the Spójnia Sunday programs initiated for 2019.

The first is the Irene Jugan "Heart and Soul" award. She reported that 3 nominations were received as of the board meeting. More are expected prior to the deadline of September 15, 2019. The winner will be announced at the convention.

The second program is the remembrance program using Facebook. Director Nemkovich reported that members and participants are being encouraged to submit pictures to the home office with a write-up of a fond memory of Irene Jugan. As of the meeting several pictures and memories have been posted.

Director Nemkovich noted that information about both programs was published in the Starz and distributed in the packet of information sent to the Clergy of the PNCC. The clergy were asked to remember Irene with special intentions at mass during Spójnia Sunday.

Officer Salary Recommendation

The board engaged in discussion regarding salary to be offered as compensation to the part time CEO. This discussion also involved a salary recommendation for the position of the CFO/Secretary.

**The National Polish-American Sports Hall of Fame (NPASHF) was founded in 1973 to honor and recognize outstanding American athletes, both amateur and professional, of Polish descent. This virtual version of the Hall features the history of their accomplishments.**

**Inducted June 20, 2019**

Allison "AJ" Mleczek played college hockey at Harvard, leading the Crimson to the NCAA title in 1999. In her senior season as captain, she scored 37 goals, 77 assists, and 114 points in only 34 games, the most prolific scoring season in women's college ice hockey history. Named to the All-American team, Mleczek won the Patty Kazmaier Award, given to the women's top college hockey player.

She competed at two Olympics leading her team to the gold medal in 1998 and the silver medal in 2002.

**Wayne Gretzky** transcends hockey. He is a living legend. Like Michael Jordan for basketball or Babe Ruth for baseball, his place in history is unquestioned.

The Great One held, or shared, 61 different NHL records upon his retirement in 1999. Some of the more impressive achievements include: Most goals in a season (92), most assists in a season (163), most points in a season (215), most career regular season goals (894), assists (1,962), and hat tricks (50). Gretzky's goal scoring was (and is) the thing of legend.

Gretzky was inducted into the Hockey Hall of Fame in 1999 as a player.

### Dan Marino

Not only was he one of the most prolific passers in the history of the NFL, he is also Polish. This nine-time Pro Bowl selection held 30 NFL records when he retired in 1999 – including most career touchdowns, career yards passing, single season yards passing, single season touchdown passes. Though several of his records have been broken, his place in history remains firmly intact. Marino is considered, by many, to be the greatest quarterback to ever play in the NFL. He was elected to the Pro Football Hall of Fame in 2005.

### Paçzki Recipe

In Poland, they are eaten especially on Fat Thursday (the last Thursday before Lent). Many Polish Americans celebrate Paçzki Day on Fat Tuesday (the day before Ash Wednesday). Traditionally, the reason for making paçzki was to use up all the lard, sugar, eggs and fruit in the house, which are forbidden during Lent.

#### Ingredients

12 egg yolks  
1 teaspoon salt  
2 packages dry yeast  
1/3 cup butter or margarine  
½ cup sugar  
1 cup of whipping cream  
3 tablespoons of rum  
3 cups flour  
1 cup prune butter (or fruit jam)  
Frying oil  
3 tablespoons powdered sugar

#### Directions

Beat 12 egg yolks with 1 teaspoon of salt at high speed until mixture is thick and piles softly (about 7 min). Separately, add 2 pkg active dry yeast to a bowl containing 1/4 cup warm water to soften.

Cream 1/3 cup of room-temp butter or margarine, gradually adding 1/2 cup of sugar, until fluffy. Stir 1 cup of flour into yeast mixture.

Add 3 tablespoons of rum and 1/2 cup pre-scalded whipping cream, then beat in another 1 cup of flour and stir in another 1/2 cup of whipping cream.

Beat in another cup flour and the yolk mixture, beating about 2 min. Gradually beat in 1-1/2 cup flour and continue beating until air blisters appear in dough.

Cover dough with plastic wrap and place in a warm place to rise. When doubled in bulk, punch down, cover again and when it rises again, punch it down.

Roll dough out on floured board 3/4" thick. Cut into 3" rounds. Place a spoonful of very thick jam (powidła, rose-hip jam) at center of half the rounds.

Brush edges of rounds with water and top with remaining rounds. Pinch edges together to seal and shape snowball-fashion into balls.

Cover paçzki and keep in warm place until doubled in bulk (about 20 min).

Fry paçzki in hot (365°F) oil to a nice golden brown on both sides.

Transfer to absorbent paper and let cool.

The Affair at Little Egg Harbor occurred in Little Egg Harbor Township, NJ on October 15, 1778 and is also known as the Massacre at Little Egg Harbor. On October 6, 1778, British forces made an attack on the village of Chestnut Neck, located about five miles southwest of here. Afterwards, the British ships involved in the attack remained in the waters of Little Egg Harbor, waiting for weather conditions to allow them to sail safely back to British-occupied New York City. (See the Port Republic page for details of the Battle of Chestnut Neck.)

A group of American soldiers under the command of General Casimir Pulaski had been sent to defend Chestnut Neck, but they did not arrive in the area until October 8, two days after the Battle of Chestnut Neck. They encamped in Little Egg Harbor Township, where they could keep an eye on the British ships still in the waters nearby. One group of fifty of Pulaski's soldiers made their camp near where the monument now stands, on what was known as Ridgeway Farm. Pulaski made his headquarters about a half mile to the west, on what was known as Willets Farm. Other groups of his soldiers were encamped nearby.

On October 13, the British in the harbor received information of the camp position and troop strength of Pulaski's forces, and they decided to make a sneak attack. Two hundred and fifty British soldiers under the command of Captain Patrick Ferguson came ashore at the southern tip of Little Egg Harbor Township late on the evening of October 14. The area where they came ashore is known as Osborn Island, because it was owned by a Quaker family named the Osborns. Ferguson and his men forced a member of the family, 29-year-old Thomas Osborn, to act as a guide to lead them to Pulaski's forces. They traveled through the dark along a road called Island Road (present day Radio Road). Early on the morning of October 15, Ferguson's men made a surprise attack on the group of about fifty of Pulaski's troops encamped on Ridgeway Farm near here. They killed or wounded most of them, and took only about five prisoners.

When Pulaski heard the sound of gunfire, he rushed to the scene with his cavalry. However, the British had attacked and left so quickly that Pulaski's men arrived after the British were already gone.

Pulaski's troops attempted to go after Ferguson's troops but were unable to catch them. Ferguson's men had removed the planks from a bridge on Island Road, leaving Pulaski's troops unable to cross. Ferguson's troops made it back to the British ships in the waters outside Little Egg Harbor. The ships remained there for another week, because weather conditions prevented them from leaving sooner. Eventually, they were able to leave on October 22, when they sailed back to New York City.

In the two years following the Affair at Little Egg Harbor, Casimir Pulaski and Patrick Ferguson both lost their lives in Revolutionary War battles. By coincidence, each was killed in a battle which took place in the South, and they died in the two following Octobers - Pulaski in October 1779, and Ferguson in October 1780.

**General Casimir Pulaski was born on March 6, 1745, in Warsaw, Poland. In 1777 he came to America to fight on the American side in the Revolutionary War. He commanded a group of cavalry which was formed in 1778 [5] known as Pulaski's Legion, and he is remembered as the "Father of American Cavalry." He died on October 11, 1779 from wounds suffered at the Battle of Savannah, Georgia.**
