Polish Christmas Traditions

Christmas Eve Supper, known as wigilia, is one of the most longstanding and widely cherished of Polish rituals. In the vast majority of homes, both among believers or non-believers, a formal meal is celebrated and served on the table which is covered with a white tablecloth. Hay is traditionally placed under the cloth covering the table and an extra empty place is set for an unexpected visitor. Custom dictates that there should be twelve dishes, just like the Twelve Apostles, and that the celebration should start when the first star appears. The most eagerly anticipated part of Christmas Eve, both for children and adults, is quite naturally the exchange of presents. There are many customs and institutions related to the entire Christmas period. They include caroling or carol singing, as well as the singing of melodious seasonal songs called pastoralki. Traditional Nativity plays are held and the art of building Christmas cribs continues to this day, especially in the South of Poland – the Krakow cribs are particularly famous. Maybe only the custom of Christmas fortune-telling, which in the past was considered as determining the course of events for the entire coming year, has not survived.

A Christmas Message from the CEO

"For a child is born to us, a son is given to us; upon his shoulder dominion rests. They name him Wonder-Counselor, God-Hero, Father-Forever, Prince of Peace."

Isaiah 9:6 (NAB)

As I reflect on this passage, it takes me back to a time in my life when I would be driving home from work, listening to my cassette with Handel's Messiah performed by the Mormon Tabernacle Choir blaring in my car as I sang this at the top of my lungs. While the Hallelujah Chorus is the most famous, this is my favorite. During this time of year we are watching and preparing for the arrival of our Lord and Savior Jesus Christ. While we are commemorating the birth of our Lord on December 25, we are also preparing for his second coming.

This preparation then takes me into the next phase of the message of Christmas that is most important to me:

"And there were shepherds living out in the fields nearby, keeping watch over their flocks at night. I bring you good news that will cause great joy for all the people. Today in the town of David a Savior has been born to you; he is the Messiah, the Lord. This will be a sign to you: You will find a baby wrapped in cloths and lying in a manger."

Luke 2:8-12 (NIV)

How terrifying it must have been for the shepherds minding their own business in the fields when the angel of the Lord appeared. How these lowly people, not great leaders, but everyday folks like you and me, were greeted by the angel and given great news of the Savior being born as foretold by Isaiah.

With all the things that have happened in 2020 with the pandemic, not seeing friends and family for months at a time, not being able to attend worship, it is comforting to know that this constant remains, that there is much hope. PNU Announces Direct Premium Payment Option

Recently the PNU established the ability to allow for premiums to be paid direct from a member's checking or savings account. This is more commonly referred to as a direct debit or ACH transaction.

Members who received their premium bills for the month of April were the first to be alerted to this new service. A form was included to complete in order to request automatic payment of premium. The ACH option eliminates the need to either mail or physically present a premium payment at the Home Office.



Education & Youth's Flash Sale Fundraiser



(Excerpt) Polish Christmas Wafer: A Flavorless Tradition That's Oh So Sweet By Sarah Zielinski

Nothing says "I love you," at least in my Polish-American family, quite like the sharing of a thin, flat, tasteless wafer called an oplatek at Christmas. We're not alone. Before sitting down to Christmas Eve dinner, many families with roots in Poland and other Eastern European countries will take part in this tradition, which has roots dating back hundreds of years. "For us, Polish Americans, the oplatek, that wafer, is Christmas Eve," says Sophie Hodorowicz Knab, author of the book Polish Customs, Traditions and Folklore. "It defines people's heritage."


Christmas Eve marks the end of Advent. Traditionally, that meant the last day of fasting, so in mostly Catholic Poland, the dinner was typically meatless. The menu might have included items such as pea soup, boiled potatoes, fried fish and stewed fruits, Knab notes in The Polish Country Kitchen Cookbook.

The Agenda and minutes from the August 27, 2020 meeting were sent out by Director Christine Wachna. Upon motion made by Robert Maycan and seconded by Christina Danielkiewicz, the Proposed Agenda was accepted. Motion carried. The minutes from the August 27, 2020 meeting were accepted as presented upon motion made by Teri Heath and seconded by Catherine Kowalczyk. Motion carried.

Correspondence: There was correspondence regarding branch mergers and it will be presented as part of New Business.



Polish Gingerbread Cookies Recipe (From Cover)

Ingredients

For the Cookies:

2 large eggs

1 cup sugar

1 teaspoon cinnamon

1 teaspoon ginger

1/2 teaspoon cloves

2 teaspoon baking soda (dissolved in 3 tablespoons water)

1 cup honey

3 cups all-purpose flour

For the Chocolate Glaze (Optional): 4 ounces semisweet chocolate (chopped)

4 ounces butter

1 tablespoon water

Step 1 Gather the ingredients.

Step 2 In a large bowl, beat the eggs with sugar until light and lemon colored

Step 3 Add the spices, baking soda-water mixture, and honey. Mix well

Step 4 Add flour gradually and mix until a soft dough forms. Shape into a ball, wrap in plastic, and let it rest for 30 minutes

Step 5 Preheat oven to 440 F. On parchment paper cut to fit your baking pans, roll the dough to 1/4 - inch thickness

Step 6 Cut into your desired shape. Lift the parchment paper by opposite corners and place on the banking pans.

Step 7 Bake for ten minutes or until lightly brown around the edges. Let cool completely. Ice or glaze right before serving


